### **Applying for a Refund**

Parking Tax paid in error will be refunded, provided that the refund application is received by TransLink within **four years** from the date the tax was paid. For example, if Parking Tax was paid in error on August 12, 2021, the refund application must be received by TransLink by August 11, 2025.

Claims for amounts of less than \$10 are not eligible for refund.

#### **COMPLETING THE APPLICATION FORM**

The Application for Refund form is available on TransLink's Parking Tax website. Hard copies of the form can also be requested from Parking Tax Services.

All refund applications must be signed by the person who paid the Parking Tax in error. Where the person who paid the tax is a corporation, the refund application must be signed by a director or authorized employee of the corporation.

All refund applications must include satisfactory documentation verifying payment of the tax and the date the tax was paid.

**Please note:** If it is subsequently determined that the basis for a refund was inaccurate or incomplete and the claimant received a tax refund in excess of the amount due, the claimant may be assessed for the excess amount plus interest.

## Appealing a Disallowed or Reduced Refund Claim

### APPEAL PROCEDURES

All refund claims are approved by the Parking Tax Administrator. If a refund claim is disallowed by the Administrator, or the amount refunded is reduced or the refund recipient is assessed for the overpayment, the taxpayer may appeal the disallowance, reduction, or assessment.

An appeal must be made within **90 days** of the date on the letter that notifies the taxpayer of the disallowance or reduction of the refund claim. The appeal must be in writing and addressed to:

The appeal must clearly state the reasons for appeal and all relevant facts.
